## ITEM III – PROFESSIONAL REPORTS

Attorney - Mr. Richard S. Cedzidlo, Esq.

Mr. Cedzidlo reviewed Communication #10 letter to Garbarini & Co P.C. RE: No pending Litigation at this time.

Mr. Curreri presented the Board and Mr. Cedzidlo with a request that was received via email concerning the Scientific Chemical Company at the corner of Paterson Plank Road and Gotham Parkway. The Company FTI consulting is seeking information in regards to any sewer hookup the company might have been involved with the CSA. According to Mr. O'Neil from FTI Consulting Mr. Crifasi did supply him with information last year. As of this notification there are no records or files on what was discussed prior with Mr. Crifasi. By way of background information. Assuming SCP was forced legally to comply with the mandate, we would like to confirm any start/stop dates that the hook-up might have been in place, and whether you might have any complaints on file regarding SCP discharges. Mr. Cedzidlo has been authorized by the Board to contact FTI consulting for review.

## Engineer -Mr. Berliner, Neglia Engineering

Mr. Berliner reported that the request for information regarding information request for the New Meadowlands Rebuild by Design Feasibility Study.

- 1. A map of the interceptor sewers (domestic and storm) with capacities. (The Sewerage Authority can only provide sanitary sewer information within their district. All storm drain information must be obtained through the Borough).
- 2. A list of pump stations (domestic and storm) with their capacities. (We will provide the requested capacities, however a Borough owned Pump Station exists on the west side of the town outside of the Meadowlands District. Would you still require the information for this Pump Station?)

- 3. GIS and/or model data for the domestic and storm sewer system. (We will provide GIS mapping for the sanitary sewers within the Authority's jurisdiction and the remainder of the request must be obtained through the Borough).
- 4. A drainage plan for the town. (This request relates to the Borough and not the Authority).
- 5. The most current Town Master Plan (This request relates to the Borough and not the Authority).

All required Insurance Certificates, Certificates of Liability Insurance and other documents have been provided to me all of the documents are in order and we are able to proceed with the installation of Door Replacement Project at Barrel Ave station.

Mr. Berliner discussed the possibility of the CSA purchasing approximently 5 water usage meters to be connected to faucets for any customers requesting a credit from their sewer user charges for water used that will not be discharged into the sanitary sewer.

Mr. Curreri would keep the meters at the Offices of the CSA and when requested will furnish the customer with the meter for more than 5 days. Anyone requesting credit for irrigation or outdoor usage will be required to install at their cost to install a permanent meter which shall be available for reading at the Authorities request. We are also investigating a reduction based on square footage of area serviced by automatic lawn sprinkler, either reduce usage by how many sprinkler heads or service area. Mr. Berliner should have more details for our April meeting.

### ITEM V – OLD BUSINESS

Mr. Curreri reported: Collections for first quarter billing is \$296,651.00 \$9,768.00 still outstanding. Second Quarter billing will be going out first week of April including late fees. Two accounts still outstanding from 2015 Icarus Group and Brake O Rama, between the two accounts it amounts to \$1,118.24 a letter was sent to both locations requesting payment and notified the responsible parties that payments will be sent to the Borough for a Tax Lien.

From 2014 and 2015 Ashtin Truck repair submitted full payment for 2014, 2015 and 2016 after Mr. Curreri sent a letter to the landlord in Queens NY requesting that all charges be paid in full or the charges due would be sent the Borough for upcoming ax Lien. John farina from Garbarini, our auditor, has the 2015 Audit 80% completed. A completed bound copy will be delivered to all Board when completed, Mr. Farina estimated the Audit should be completed by April 10. Mr. Curreri will deliver the Audit separate from the meeting packages when received.

Mr. Curreri requested the assistance of Mr. Cedzidlo in responding to request for information of the old Scientific Chemical site from FTI consulting the board agreed that Mr. Cedzidlo should respond due to the fact that FTI consulting already information that was distributed to them from Mr. Crifasi and the fact that Mr. Curreri has no knowledge of what was furnished by the CSA in the past.

Mr. Curreri discussed the possibility of having to replace the manhole in front of 100 Commerce Blvd that was uneven and in need of asphalt patching. Mr. Curreri will meet with Neglia at the site to discuss measures to repair or replace manhole.

Mr. Curreri advised the Board members to submit Financial Disclosure statements to the State before the end of April.

Board members were polled to confirm anyone going to the NJWEA Conference May 16 through May 20, 2016 Please have any request to attend for Aprils meeting.

Immediately following our meeting as requested by the Board at February Meeting Mr. Covelli from PIA Insurance will have a Presentation for all Elected and Appointed officials in the JIF. The elected Officials Training Seminar will qualify the CSA for a \$250.00 per official refund from our yearly Liability Insurance cost.
